The Committee agreed to have a negotiation meeting with the recommended firm Flexmond Services Limited on areas such as the workplan/methodology, payment terms, Terms of reference and total contract sum.

10. NEGOTIATION

A meeting was held on December 9, 2019 at the School of Graduate Studies' Conference Room, UENR to negotiate on some terms in the recommended Consulting firms' submission for the Request for Proposal (Tender).

10.1 AGREEMENT REACHED BY THE PARTIES

Upon an extensive deliberations and discussions, the parties agreed on the following;

- 1. The duration for the entire project will be revised from 30 months to between **18-24months**.
- 2. Total Contract Sum was adjusted from GH¢ 992,250.00 to GH¢ 800,000.00.
- 3. The payment terms is as follows;
 - 10% payment of the total contract sum upon the signing of the contract
 - 30% payment of the total contract sum upon the completion of the pre contracting stage
 - •The remaining 60% will be spread over the construction period.

11. FINAL RECOMMENDATION FOR THE AWARD OF CONTRACT

The Evaluation panel, after analyzing all the qualified proposals, decided that based on the evaluation which was conducted in accordance with the evaluation criteria indicated in the tender document, the Evaluation Panel recommended **Flexmond Services Limited**, whose proposal was considered the best proposal that offers the best quality and cost for provision of the service at a total contract sum of eight Hundred thousand Ghana Cedis (GH 800,000.00) after negotiation meeting for the award of contract.
